Upon acceptance of this application, the undersigned shall receive the rights and privileges and agrees to abide by all the rules and policies of the Creve Coeur Racquet Club which are subject to change without notice and which, in the option of the club management, are deemed necessary and reasonable for the best interests of its members. I understand that my membership may be terminated by the Creve Coeur Racquet Club if I am in violation of the club rules, regulations and policies, conduct myself in a manner in which management deems inappropriate or disruptive to other members of the club or make false representation of information contained in this application. I will not be entitled to any refund of the initiation fee or dues paid up to the date of termination. Upon termination of my membership I am responsible for any outstanding balance due. Creve Coeur Racquet Club may be closed during certain legal holidays, and use of the club or facilities is also subject to interruption for needed repairs and maintenance. I understand that the initiation fee is a one-time charge, contingent upon a continuous membership and must be included with the application. After the initial membership year, if I elect to pay in full, the membership is annual and self renewing and may be terminated only at the end of the annual period in writing. The initial payment of membership fees and monthly dues is not refundable unless cancelled in writing within three days after purchase. I hereby release CC Racquet Club LLC, Creve Coeur Management Company, its owners and employees from any and all liability for any damage or injury which I and my family may receive while utilizing the equipment and facilities and assume all risks for claims arising from the use of said equipment and facilities. ## Reservation Of Court Time

Courts may also be reserved for one and one-half hours if desired. Unreserved courts may be used at the going rate. All indoor applicants who have paid their season dues and all Full Club Members who have paid their initiation fee will receive an Indoor Tennis Reservation Request Form for the upcoming season. Reserved time will be confirmed on a renewal priority basis until July 31. After July 31, indoor time, as available, will be scheduled at the standard hourly rate upon request.

\*Cancellation of Open Play court time must be made 24 hours in advance to avoid charges

## Guests

Members may invite guests to use the facilities of the club with them. All Members may not bring the same guest on more than three (3) occasions total. No member may bring more than three (3) guests to the Club at the same time. Members must sign and pay fees for the use of the Club facilities by their guests and charges incurred by or for their guests at the Club. Member should remind their guests of the White Rule on the tennis courts. Dress Code—White attire only on courts—up to 1/2 color trim is acceptable.

## Lessons

Lessons are available upon request from the Club Professionals. All Charges for lessons will be billed to the members account monthly.

## Services

For the convenience and comfort of the members, a complete Training Center, Pro Shop, Locker Rooms and complete Food and Cocktail Services are available.

## Member's Accounts

Charges to members for Goods & Services will be on a credit basis. Statements for charges at the Club will be rendered monthly. An 18% service charge will be added to food and beverage purchases; CCRC may increase service charge anytime at it's sole discretion. Statements are due and payable upon receipt. Accounts past due over 30 days will be charged an interest rate of 18% per year. Any accounts that reach a delinquent status of 60 days or more past due and remain as such for more than 1 billing cycle, or 30 days, will be required to provide a valid MasterCard or Visa credit card to guarantee account. All current and future amounts due will be applied to the valid credit card provided. Until such credit card information is received and the account is paid in full, the account will be suspended and no admittance will be allowed whatsoever. Members are subject to termination once suspension has been invoked. If the account shall be placed in the hands of an attorney for collection, the member agrees to pay all costs of collection including attorneys fees for such collection whether or not a suit is filed.

## Full Club Membership Privileges

Full Club Members are entitled to all the amenities of the club. Fifteen outdoor courts at no charge, pool privileges, the ability to book indoor courts, training center, a full service restaurant, all the club parties, use of locker rooms and showers, and preferred pricing on clinics and leagues.

## Full Club Membership

### Leave of Absence Policy

Full Club Members may choose to put their account on an inactive status ONLY after one year of active full club status. The Leave of Absence entitles the member to temporarily 'freeze' their Full Club Account, suspending the monthly dues charges and waiving the initiation fee upon reactivation of the account. During this period, the member's account is put on an "Inactive" status with all club privileges temporarily put on hold. An annual fee of \$90.00 will be charged to the account. If the membership is in demand the inactive member will have 30 days to choose the option of reactivating or resigning membership after receiving written notice from management of Creve Coeur Racquet Club. The inactive Membership must remain inactive for one year to avoid back payment of Club Dues.
